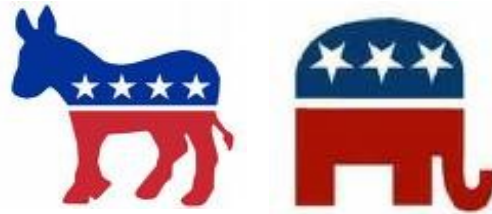
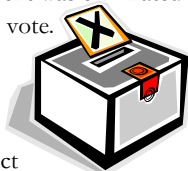

Every Vote Does Count

Over the years, Americans have worked and fought to extend voting rights to every citizen:

- 1787 - Only white land owners age 21 or older could vote.
- 1807-1813 - "Land Owner" requirement was eliminated.
- 1870 - All men age 21 or older could vote.
- 1920 - Women could vote.
- 1964 - Poll Tax was eliminated.
- 1971 - Voting age lowered to 18.
- 1990 - Americans with Disabilities Act



You **DO NOT REGISTER BY POLITICAL PARTY** in Alabama. In Primary & Primary Runoff elections **YOU WILL BE ASKED YOUR PARTY PREFERENCE AT THE POLLING PLACE** & you will be given a ballot listing only candidates affiliated with that party. In Alabama, cross-over voting from a Primary to a Primary Runoff is not allowed & is considered a Class C Felony. Ala. Code § 17-17-36

ABSENTEE BALLOT INFORMATION

If you are sick, going to be out of the county, or handicapped and cannot get to the Polls, you may vote by Absentee Ballot. You must apply for an Absentee Ballot either in person or by mail. The Circuit Clerk's office will provide you with an application form for an Absentee Ballot any time prior to an election, right up to 4:30 p.m. on the **Thursday** before the next **Tuesday** election. You may either pick up an application form at the Circuit Clerk's office, print one online, or call the office at [256/351-4794](tel:2563514794) and one will be sent to you in the mail. A copy of your valid ID is required to accompany your application.

You may also write the Circuit Clerk using a plain piece of paper that lists the following:

1. Your full name as it appears on the voter's list.
2. Your Morgan County Address. (If it is different from the voter's list, give us your old and new address.)
3. Your date of birth.
4. Your Social Security Number (optional).
5. Your voting place.
6. Address where you want the ballot sent.
7. A telephone number where you may be reached.
8. Your reason for voting Absentee.
9. If Absentee request is for Party Primary or Run-off, list your Political Party preference.
10. Specify if request is for Party Primary, Party Runoff, Municipal, Special, General Election, or ALL elections for the year.
11. Sign the request. (If you sign by mark, you must have a witness sign the request.)



Applicants may register the same day that they move into the county. If you move within Morgan County or changed your name you must notify the Board of Registrars office in writing, update your registration via alabamavotes.gov or you can update your voter file in the Registrars office between the hours of 8:00 a.m. and 4:30 p.m. Monday through Friday. **Know a voter who has died or moved out of Morgan County?** If you do, please call our office so we may keep our records as up-to-date as possible. We will independently verify the information you provide us before removing the voter from the Voter's List.

HOW TO HANDLE YOUR ABSENTEE BALLOT

If you are eligible to vote an Absentee Ballot, you may vote in person at the Circuit Clerk's office any time after it receives the Absentee Ballots (usually 45 days before the election). You may have your ballot mailed to you. If you receive your ballot by mail, YOU MUST do the following:

1. Mark your ballot.
2. Fold your ballot and place it inside the **inner** envelope and seal.
3. Place the **inner** envelope inside the **outer return mail envelope** and seal.
4. You must fill out the affidavit on the outside of the return mail envelope and it **must be signed by a notary public or two adult witnesses.**
5. Deliver the completed ballot to the Circuit Clerk's office in person, by USPS mail, or 3rd party commercial carrier (UPS, FedEx, etc.) to arrive by election day!

Only the voter may hand deliver the completed ballot to the Circuit Clerk's office. Not a spouse, relative or friend! The completed ballot can also be mailed in your individually sealed envelope, mail your request to:

IMPORTANT NOTICE

CODE OF ALABAMA, 2007, Section 17-9-10, provides "At all elections held within this state, the elector shall vote in the county and voting place of his or her domicile and nowhere else and shall have registered as provided in this title. If any elector attempts to vote in any voting place other than that of his or her domicile, his or her vote shall be rejected, except when casting a provisional ballot, as provided by law."
