

FCPA Filing Calendar - 2010 Election Cycle

| Date | Activity |

| June 1, 2009 | Candidates intending to participate in the 2010 primary election may begin soliciting and accepting contributions |
| November 2, 2009 | Candidates intending to participate in the 2010 general election, but not in the primary election, may begin soliciting and accepting contributions |
| January 12, 2010 | Regular legislative session begins. |
| January 12 thru January 31 | Blackout period for soliciting and receiving contributions |
| January 30, 2010 | Certified mail deadline for the annual report |
| February 1, 2010 | Deadline for candidates and political committees to file annual report (Deadline falls on Sunday) |
| April 2, 2010 | Last day candidates may qualify with political parties to participate in primary election |
| April 12, 2010 | First day to file the 50/45 day pre-election report for the primary election |
| April 17, 2010 | Certified mail deadline for the 50/45 day pre-election report for the primary election |
| April 19, 2010 | Deadline to file 50/45 day pre-election report for the primary election |
| May 21, 2010 | Last day to register to vote for the primary election |
| May 24, 2010 | First day to file 10/5-day pre-election report for primary election |
| May 25, 2010 | Certified mail deadline for the 10/5-day pre-election report for the primary election |
| May 27, 2010 | Last day to file 10/5-day pre-election report for the primary election |
| May 31, 2010 | State Holiday (Memorial Day) |
| June 1, 2010 | Primary Election |
| June 1, 2010 | Last day to file petitions with probate judge for county offices and with secretary of state for other offices to obtain ballot access as an independent candidate |
| June 7, 2010 | State Holiday (Jefferson Davis' Birthday) |
| July 2, 2010 | Last day to register to vote for the primary runoff election |
| July 6, 2010 | First day to file 10/5-day pre-election report for the primary runoff election |
| July 6, 2010 | Certified mail deadline for the 10/5-day pre-election report for the primary runoff election |
| July 8, 2010 | Last day to file 10/5-day pre-election report for the primary runoff election |
| July 13, 2010 | Primary Runoff Election |
| September 6, 2010 | State Holiday (Labor Day) |
| September 13, 2010 | First day to file the 50/45 day pre-election report for the general election |
| September 18, 2010 | Certified mail deadline for the 50/45 day pre-election report for the general election |
| September 20, 2010 | 50/45 day pre-election report due for general election |
| September 29, 2010 | Last day candidates in primary election can accept contributions to retire a campaign debt |
| October 11, 2010 | State Holiday (Columbus Day) |
| October 22, 2010 | Last day to register to vote for general election |
| October 25, 2010 | First day to file 10/5-day pre-election report |
| October 26, 2010 | Certified mail deadline for the 10/5-day pre-election report for the general election |
| October 28, 2010 | Last day to file 10/5-day pre-election report for the general election |
| November 2, 2010 | General Election |
| November 10, 2010 | Last day candidates in primary runoff election can accept contributions to retire a campaign debt |
| January 29, 2011 | Certified mail deadline for annual report |
| January 31, 2011 | 2010 annual report due (on or before January 31 of the succeeding year) next after general election |
| March 2, 2011 | Last day candidates in general election can accept contributions to retire a campaign debt |
